The Bristol Junior Chamber is a not-for-profit organisation and its income is derived from its membership fees, tickets for certain events and its activities. Any surplus from our activities is re-invested into the Chamber or donated to our charity fund held by Quartet.

The fees for the current financial year are:

- £49.50 joining fee (a one-off payment upon joining);
- £170 annual membership fee (running from 1 April each year);
This fee can be reduced on a pro rata basis depending on when you join in the year. Invoices are normally issued in April.
- Please note that we are not VAT registered.
